CAPITAL ORDINANCE NO. 2021-06

**CAPITAL ORDINANCE PROVIDING FOR THE IMPROVEMENTS TO PARK, AND
APPROPRIATING \$230,000 THEREFOR, AUTHORIZED IN AND BY THE
TOWNSHIP OF SHREWSBURY, IN THE COUNTY OF MONMOUTH, NEW JERSEY**

WHEREAS, the TOWNSHIP Council of the TOWNSHIP of Shrewsbury, in the County of Monmouth, New Jersey (the "TOWNSHIP") has determined to IMPROVEMENTS TO PARK; and

WHEREAS, the TOWNSHIP has \$115,000 in the Capital Improvement Fund and \$115,000 from The County of Monmouth Open Space Grant.

NOW, THEREFORE, BE IT ORDAINED by the TOWNSHIP COMMITTEE OF THE TOWNSHIP OF SHREWSBURY, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general capital improvements to be undertaken in and by the TOWNSHIP of Shrewsbury, in the County of Monmouth, New Jersey (the "TOWNSHIP"). For the improvements or purposes described in Section 2, there is hereby appropriated \$230,000, said sum being inclusive of \$115,000 from the Capital Fund Balance and \$115,000 from The County of Monmouth Open Space Grant.

Section 2. The purchase hereby authorized to be undertaken is for the IMPROVEMENTS TO PARK together with all purposes necessary, incidental or appurtenant thereto, all as shown on and in accordance with contracts, plans, specifications or requisitions therefor on file with or through the TOWNSHIP Clerk, as finally approved by the governing body of the TOWNSHIP.

Section 3. The 2021 capital budget of the TOWNSHIP will conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the TOWNSHIP Clerk and is available there for public inspection.

Section 4. The TOWNSHIP Attorney and other TOWNSHIP officials and representatives are hereby authorized to do all things necessary to accomplish the purposes of the appropriation made herein.

Section 5. This ordinance shall take effect as provided by law.
