RECOMMENDATIONS

Financial Administration

Comment 2021-001:

We noted various reserve whereby a dedication rider resolution approval was not obtained by from the State of New Jersey.

Recommendation:

That the Township obtain dedication by rider resolution approvals from the State of New Jersey for all trust fund reserves.

Expenditures

Comment 2021-002:

Our examination of expenditures revealed deficiencies in the application of the Township's internal control policies and procedures over expenditures. We noted the following deficiencies: (a) the invoice date for 10 out of 25 items tested was prior to the purchase order date; (b) there was no "Claimant's Certification & Declaration" signature for 17 out of 25 purchase orders tested; and (c) emergency purchases did not have authorizing resolution of the governing body.

Recommendation:

That the Township adhere to its internal control policies and procedures over expenditures.

A Corrective Action Plan, which will outline actions the Township of Shrewsbury will take to correct the findings listed above, will be prepared in accordance with federal and state requirements. A copy of it will be placed on file and made available for public inspection in the Office of the Municipal Clerk within sixty (60) days of receipt of the audit report by the governing body.
