ORDINANCE AMENDING AN ORDINANCE RELATING TO TRAFFIC IN REGULATING THE USE OF PUBLIC STREETS AND PUBLIC PARKING LOTS IN THE TOWNSHIP OF SHREWSBURY, DEFINING AND PROVIDING FOR THE ESTABLISHMENT OF PARKING SPACES UPON THE PUBLIC STREETS AND PARKING LOTS, AND FOR THE ENFORCEMENT THEREOF AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF ORIGINALLY ADOPTED

SEPTEMBER 14, 1993 AND AMENDED OCTOBER 13, 2009

BE IT ORDAINED by the Township Committee of the Township of Shrewsbury, County of Monmouth, State of New Jersey as follows:

WHEREAS the Township of Shrewsbury may make, amend, appeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of the State of New Jersey or the United States as it may deem necessary and proper for the good government, order and protection of persons and property and for the preservation, the public health, safety and welfare of the Township of Shrewsbury and its inhabitants and as may be necessary to carry into effect the powers and duties conferred and imposed by the laws of Shrewsbury Township in the County of Monmouth in the State of New Jersey pursuant to N.J.S.A. 40:48-2.

NOW THEREFORE BE IT ORDAINED AND ENACTED, by the Township Committee of the Township of Shrewsbury in the County of Monmouth in the State of New Jersey that the ordinance entitled "Ordinance Amending and Ordinance Relating to Traffic in Regulating the Use of Public Streets and Public Parking Lots in the Township of Shrewsbury, Defining and Providing for the Establishment of Parking Spaces Upon the Public Streets and Parking Lots, and for the Enforcement Thereof and Providing Penalties for the Violation Thereof" as adopted September 14, 1993 and amended October 13, 2009, is hereby amended as to Article IX and add Article X as follows:

Article IX. Limiting the Weight of Motor Vehicles.

Section 3. Penalties.

This Section shall be deleted.

Article X. Special Parking in Parking Lot at 1979 Crawford Street, Shrewsbury Twp.

Section 1. Special Parking:

The Township shall allow for three (3) marked and posted parking spaces on the side of Municipal Hall in the Municipal Parking Lot for "Permit Parking" on a first come, first served basis, for trailers of residents of Shrewsbury Township Only, as defined as a vehicle for the conduct of any business, profession, occupation or trade, and as designated that it has been or may be mounted upon wheels and used as a conveyance upon highways or streets and shall not extend beyond that which would obstruct or prohibit other trailers or vehicles to park in the designated area of the parking lot.

Section 2. Permit Parking

The aforesaid shall be Subject to an Application and Permit Fee of \$200.00 per year; along with proof of insurance, ownership and residency in Shrewsbury Township.

Section 3. Penalties.

Penalties for violation of any section to this Ordinance shall include abandonment of the vehicle in the public parking area and towing of said abandoned and fines not to exceed \$2,000.00; a term of imprisonment not to exceed 90 days or community service not to exceed 90 days or any combination thereof.

BE IT FURTHER ORDAINED that each section, subsection, clause and phrase of this ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this ordinance to be unconstitutional, void or ineffective for any cause or reason shall not affect any other portion of this ordinance or the general Parking Ordinance of which it is a part.

BE IT FURTHER ORDAINED AND ENACTED, that this ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
