The use of ASPCA, a sponsorship type costs a lot of money and usually used in larger towns. 2<sup>nd</sup> type, an agency is created in the town, not doing. 3<sup>rd</sup> type is a caretaker type ordinance that establishes responsibilities for the caretaker of the feral cats. Caretaker registers with the town and follow the ordinance. Sue V commented that 3<sup>rd</sup> type is best financially for town. Will reintroduce on May 23<sup>rd</sup>, tabled the Feral Cat Ordinance for tonight.

Discussed opinion letter on facility use, and Ordinance 2017-5. Use of facilities should be limited to non-profit organization, unless the organization is sponsored by the town, for example the recreation department. No political activities. Should be non-profit and recreation. Sue V commented that one and a half times per hour over allotted time. \$250 deposit and that would be used if party goes over allotted time. Recreation Director Richard Brunson commented that the ping pong net was damaged recently.

# TOWNSHIP OF SHREWSBURY O R D I N A N C E #2017-4

ORDINANCE PROVIDING FOR THE CONTROL OF FERAL CATS IN THE TOWNSHIP OF SHREWSBURY, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY

**WHEREAS**, the Mayor and Township Committee of the Township of Shrewsbury are aware of problems in the Township caused by an increasing feral cat population; and

WHEREAS, there are no facilities in the Township of Shrewsbury ("Township") to address issues created by feral cats; and

WHEREAS, programs for the managed care of feral cat colonies have proven to be effective in reducing the number of feral cats and is more humane than trapping and euthanizing; and

**WHEREAS,** the Mayor and Township Committee deem it in the public interest to amend its Ordinances in order to meet these stated goals:

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Mayor and Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey that the existing Ordinances concerning the licensing and controlling of cats in Shrewsbury Township shall be amended and supplemented as follows:

## Section 1. Definitions.

- A. Cat(s); means every cat, regardless of sex or age.
- B. Feral Cat(s); means a cat, regardless of sex or age, that is unowned, free roaming and not interactive with humans.
- C. Feral Cat Colony; means a group of feral cats that have been trapped, neutered or spayed and released back into the area from which they were taken.
- D. Feral Cat Colony Caretaker; means a person who has registered the colony with the Township of Shrewsbury or any delegated animal control association, and who provides sustenance, water and care for a feral cat colony.
- E. Adult Cat(s); means any cat over the age of four (4) months.
- F. Nuisance Cat(s); means any cat that unreasonably annoys humans, endangers the life or health of other animals or persons, or substantially interferes with the rights of citizens, other than their owners, to enjoyment of life or property.
- G. Owner; means every person having the right of property and a cat(s), or who keeps or harbors a cat(s), or who has a cat(s) in his/her care or who acts as a custodian of a cat(s), or who permits a cat(s) to remain in or about the premises occupied by him/her.

# Section 2. Limitations on Keeping Cat(s).

A. No owner of any cat(s) shall allow the animal to freely roam out of doors; unless it has been spayed or neutered. The owner of each spayed or neutered cat(s) shall keep a record for each cat(s) from a duly licensed veterinarian containing a description of the cat(s), the name of the owner and the date in which the spaying or neutering took place. Any cat(s) allowed to roam out of doors shall be required to wear a collar; designed to release the cat(s) should it become entangled or trapped by the collar, containing the owner's identification

- information and proof of current rabies vaccination. It shall be unlawful for any person to own, keep, hold, board or harbor more than five (5) adult cats that are allowed to freely roam out of doors. An adult cat is described as a cat over the age of four (4) months.
- B. The limitation on the number of cats owned, kept, held or harbored shall not apply to caretakers of feral cat colonies that have registered such colonies with the Township. Registration shall include the name and address of the caretaker(s), animal rescue group, if any, that they are affiliated with, and the location of the colony. A feral cat colony may be registered when the volunteer caretaker and Shrewsbury Township can assure that:
  - 1. Regular feeding of the colony will be maintained throughout the year;
  - 2. Adult cats and kittens over eight (8) weeks of age that can be captured, will be neutered or spayed and vaccinated against rabies. A three-year rabies vaccine will be administered whenever feasible;
  - 3. Every attempt will be made to remove kittens from the colony before they reach the age of eight (8) weeks for domestication and placement;
  - 4. Sick or injured cats will be removed from the colony for immediate veterinarian care or humane euthanasia;
  - 5. Cats will be earmarked for recognition of members of a registered feral cat colony; and
  - 6. Records of sterilization, vaccination and animal identification can be provided to Shrewsbury Township or its delegated animal control agency, if any, upon request.
- C. The breeding of cats for financial gain shall be prohibited.

# Section 3. Nuisance Cats.

- A. It shall be unlawful for any person to permit any cat(s) they own, keep, hold, board or harbor to:
  - 1. Damage the property of anyone other than its owner;
  - 2. Enter the property of anyone other than its owner and kill or maim domestic animals or wildlife;
  - 3. Excessively make disturbing noises, including, but not limited to, continued and repeated caterwauling, howling, whining, or other utterances causing unreasonable annoyance, disturbance or discomfort to neighbors or others;
  - 4. Foul the air with odor and thereby cause unreasonable annoyance or discomfort to neighbors or others near to the premises where the cat(s) is kept or harbored;
  - 5. Cause unsanitary conditions in enclosures or surroundings where the cat(s) is kept or harbored; and
  - 6. Be offensive or dangerous to public health, safety and welfare by virtue of number and/or types of cat(s) contained.

# Section 4. Trapping of Nuisance Cat(s).

A. The owner of property in which a feral nuisance cat(s) is present may request a live trap from any local animal control agency, which trap and remove the nuisance cat(s). The live trap must be inspected at a minimum of once every twelve (12) hours by the person who requested the trap, and animal control agency providing such trap, or the Township Animal Control Officer contacted immediately upon the trapping of the cat(s). At no time may a trapped animal remain in a live trap more than six (6) hours, and the trapped animal may

not be left in an inhuman condition or position such as adverse weather conditions or where it cannot defend itself from other dangerous animals. The traps will not be placed when the Animal Control Officer of the Township will be unavailable to pick it up the next day; i.e. weekends, holidays and when the Township Animal Control Officer will be off duty.

# BE IT FURTHER ORDAINED AND ENACTED, that this ordinance shall

take effective immediately upon final adoption and publication in the manner prescribed by law.

**BE IT FURTHER ORDAINED AND ENACTED,** that all ordinances or parts of ordinances

that are inconsistent herewith are repealed, but only to the extent of such inconsistency.

# ORDINANCE AMENDING ORDINANCE 2016-04 CREATING A NEW ORDINANCE CONCERNING THE USE OF MUNICIPAL FACILITIES AND FEES FOR VARIOUS USAGES

WHEREAS, the Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey, in 2016 updated its regulations and schedule of fees for the use of municipal recreation facilities, and to limit harm or injury to participants; and

Section 10: Fees. Should be amended as follows:

Should any participant utilizing Township fields and/or facilities make use of such B(5)

fields or facilities more than one-half hour beyond the designated time for ending such activities, then

the participant shall be charged one and one-half times per hour of the hourly rate designated by this

Ordinance apportioned out for the time period that the participant or participants extend beyond the

designated time period for ending said activity, and commencing immediately after the scheduled time

for termination of the activity, until the activity has completely ceased and the participants have

vacated the fields or facility.

BE IT FURTHER ORDAINED AND ENACTED, that this Ordinance shall be in full force

and effect from and after its adoption and any publication as may be required by law.

# REVISED SALARY ORDINANCE TOWNSHIP OF SHREWSBURY

AN ORDINANCE TO AMEND AN ORDINANCE 2016-03 and 2016-05 ENTITLED "AN ORDINANCE FIXING SALARY AND COMPENSATION OF CERTAIN OFFICES, POSITIONS AND EMPLOYEES IN THE TOWNSHIP OF SHREWSBURY, COUNTY OF MONMOUTH, NEW JERSEY FOR THE YEAR 2016" AND THEREAFTER KNOWN BY

IT'S SHORT NAME AS 'SHREWSBURY TOWNSHIP SALARY ORDINANCE'

BE IT ORDAINED, by the Township Committee of the Township of Shrewsbury in the County of Monmouth and State of New Jersey:

**SECTION 1.** The offices and positions under the Municipal Government of the Township of Shrewsbury shall be compensated at the amount fixed in this Ordinance.

**SECTION 2.** The Township Chief Financial Officer is hereby authorized to transfer such sums of money from the Municipal Current Account and other such accounts that may cover periodic payrolls in the amounts fixed by this Ordinance.

**SECTION 3.** Effective January 1, 2017 all employees, eligible for health insurance shall make a contribution of salary towards health benefits based on the annual premium for all health care and prescription premiums as set forth in the schedule promulgated by the NJ Division of Pensions and Benefits herein attached and as revised from time to time. The minimum contribution shall be equal to 1.5% of the employee's salary.

**SECTION 4.** The following listed positions are assigned to the following titles with annual salary ranges, providing for minimum and maximum salaries, contingent on merit, the availability of funds, and other provisions of this Ordinance. The Township Committee shall pass an annual resolution indicating the specific salary of each employee.

**SECTION 5.** The following positions shall be compensated in the year 2017 as follows:

**WHEREAS**, in accordance to N.J.S.A. 33:1-12, the following increase reflects a 10% increase of the 20% statutory limit allowed by a licensing agent for annual liquor license fees not to exceed \$2,500 for a Class D Plenary Retail Distribution License,

**WHEREAS**, the last increase in the fee for a Class D Plenary Retail Distribution License in Shrewsbury Township was enacted in 2016, AN ORDINANCE AMENDING FEES OF PLENARY RETAL DISTRIBUTION LICENSE FEES IN SHREWSBURY TOWNSHIP is hereby amended and supplemented as follows

Section I: The annual fee for a Class D Plenary Retail Distribution License is hereby amended to change the fees for a Class D Plenary Retail Distribution from \$720 to \$792.00. The fee specified shall take effect upon the effective date of this ordinance and shall apply to all applications for a Plenary Retail Distribution License until the same shall be changed as provided by N.J.S.A. 33:1-12.

Section II: All ordinances and provisions of the Ordinances of the Township of Shrewsbury thereof inconsistent with the provisions of this ordinance shall be and are hereby repealed to the extent of such

inconsistency. # RESOLUTION 2017-67 AUTHORIZING TONNAGE GRANT APPLICATION TO THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION

WHEREAS, the Mandatory Source separation and Recycling Act, P.L. 1987, c.102, has established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection has promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.
