

ORDINANCE 2015-12
AN ORDINANCE AMENDING RECYCLING ORDINANCE 11.24.09 ESTABLISHING
FEES AND
REGULATIONS FOR SEASONAL BULK DROP OFF

BE IT ORDAINED by the Township Committee of the Township of Shrewsbury, in the County of Monmouth and State of New Jersey, as follows:

WHEREAS the Township committee of the Township of Shrewsbury, County of Monmouth wishes to further the goals of its recycling program with a seasonal bulk drop off program, the following fees and regulations are added to the added to Ordinance 11-24.09

Section B.10

The Township of Shrewsbury may from time to time schedule a seasonal bulk drop off at the Department of Public Works facility as the annual budget permits. The dates will be advertised in advance, and participating residents must pay in advance for \$5.00 per chair, table or other miscellaneous household items not exceeding 9 cubic feet. More than one permit may be purchased. A resident must show proof of residence in the Township of Shrewsbury to purchase a permit. A permit will only be valid for that resident purchasing the permit. The resident will be given two copies of the permit receipt. The yellow copy of the receipt must be surrendered to an official of the Department of Public Works in order for the item to be accepted. The Township will not replace lost permit receipts. Permits will NOT be sold the day of bulk drop off.

The following items will NOT be accepted: mattresses, couches, construction debris, hazardous waste including paint cans, plastic bags, household garbage, mirrors, light bulbs or any other items referenced in Section B. 5 through Section B.9 of Ordinance 11.24.09. All items must be unwrapped and readily available for inspection by the Department of Public Works.

Metal items, normal recycling items, such as newspaper, paper, aluminum, electronics, metal appliances do not need permits and may be dropped off at any time during normal operating hours.

NOW THEREFORE LET IT BE ORDAINED AND ENACTED that this ordinance shall be in full force and effect from and after its adoption and any publication as required by law.
